Del Norte Local Agency Formation Commission June 23, 2014 4:00 pm

1. <u>Call to Order/Roll Call</u>

Vice-Chairman Murray called the meeting to order at 4:05 p.m.

2. <u>Public Hearings</u>

A. Del Norte County Fairgrounds Recreation and Park District Formation –

Protest Proceedings (ATTACHMENT 2A)

Executive Officer Williamson reported on the formation of the recreation and park district, including the posting of the protest proceeding. The notice was posted twice, although it was only required to be posted once. Mr. Williamson read the protests. 6 were received from registered voters and 5 from landowners in the county. The public comment period was opened at 4:08 p.m. No public comments were received and the public comment period was closed at 4:08 p.m.

On a motion by Commissioner Hemmingsen, seconded by Commissioner Gastineau, and unanimously carried on a polled vote with Commissioner Countess and Gitlin absent, the Del Norte Local Agency Formation Commission approved and adopted the Resolution 2014-04, as presented. - A. Approval of **May 19, 2014** Draft Minutes (ATTACHMENT 3A)

On a motion by Commissioner Gastineau, seconded by Commissioner Hemmingsen, and unanimously carried, the Del Norte Local Agency Formation Commission approved and adopted the minutes of May 19, 2014 as presented.

B. Approval of Professional Services Contract Extension (ATTACHMENT 3B)

George Williamson noted that he would like to continue working for the Commission and requested that the agreement extension be approved.

On a motion by Commissioner Hemmingsen, seconded by Commissioner Gastineau, and unanimously carried on a polled vote with Commissioners Gitlin and Countess absent, the Del Norte Local Agency Formation Commission approved the contract for Professional Services with George Williamson of Planwest Partners, as presented.

- A. Staff The Executive Officer will provide a report of current projects, issues of interest, and pending legislation.

Cemetery Management Options (ATTACHMENT 4A)

Executive Officer Williamson reported on: 1) on the cemetery management options and noted that a non-profit could form to take over the management. Gerry Cochran, veteran's cemetery manager, discussed the formation of a district and former failed attempts to fund a countywide cemetery district. All the cemeteries need to support the initiative in order for it to be on the ballot and that did not happen last time (2007) it was attempted. Discussion was held regarding the purpose of the sales tax and circumstances that have changed since the last time the proposal was suggested.
