#### RECOMMENDATION

The following procedures are recommended for Commission consideration of this item:

- Receive verbal report from staff;
- Open the public hearing and invite testimony; and
- Discuss item close the hearing and consider action on recommendation:
  - 1) Adopt Resolution 21-03 approving the final FY 2021-2022 budget, as shown in Exhibit A.

## BACKGROUND

Local Agency Formation Commissions (LAFCos) are responsible under State law for annually adopting a proposed budget by May 1st and a final budget by June 15th. State law specifies the proposed and final budgets shall - at a minimum - be equal to the budget adopted for the previous fiscal year unless LAFCo finds the reduced costs will nevertheless allow the agency to fulfill its prescribed regulatory and planning duties. The proposed FY 2021-22 budget was reviewed and approved by the Commission on April 26, 2021.

#### DISCUSSION

The overall budget will increase slightly to account for higher interest amounts accrued on the reserve account. County and City contributions to remain the same, as shown in attached budget (Exhibit A to Resolution 21-03). The Executive Officer sent letters to both the City of Crescent City and the County of Del Norte informing them that the City and County funding obligations would remain at FY 2019-20 and FY 2020-21 levels of \$39,852.50. Both the City Manager and the County Administrative Officer acknowledged that this amount would be reflected in their respective FY 2021-22 budgets. Municipal Services Review (MSR) and Sphere of Influence Update (SOI) preparation costs for FY 2021-22 will increase to \$32,000 from \$24,500 to account for an increased number of MSR /SOI Updates, including the Fire Protection Districts. Executive Officer services will reduce to \$40,100 from \$47,520. This amounts to an increase of \$7,500.00, and a decrease of \$7,420.00 for total increase of \$80.00. The difference will be drawn from interest income.

A FY 2021-22 CALAFCO Board Meeting travel expense allocation of \$2,200.00, from Contingency (unrestricted) Funds is requested to allow for Commissioner Inscore to participate in (as travel restrictions allow) up to four CALAFCO Board Meetings and annual conference. The Commissioner may decide to attend the meetings in person or remotely.

WHEREAS, the Executive Officer's report was presented to the Commission in the manner provided by law; and

WHEREAS, the Commission heard fully and considered all of the evidence presented at its public hearing on the final budget held on May 24, 2021; and

WHEREAS, the Commission determined the proposed budget projects the staffing and program costs of the agency as accurately and appropriately as is possible.

NOW, THEREFORE, BE IT RESOLVED by the Commission as follows:

1. The Final Fiscal Year 2021-2022 Budget as presented in Exhibit A is approved.

2. The overall operating costs provided in the final budget will allow the Commission to fulfill its regulatory and planning responsibilities as required under Government Code Section 56381 (a).

Dear Chair Aguiar-Curry:

The Local Agency Formation Commission of Del Norte County is pleased to support the Assembly Local Government Committee Bill (**AB 1581**), sponsored by the California Association of Local Agency Formation Commissions (CALAFCO), which makes technical, non-substantive changes to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 ("CKH Act").

This annual bill includes technical changes to the CKH Act which governs the work of LAFCOs. These changes are necessary as Commissions implement the CKH Act and small inconsistencies are found or clarifications are needed to make the law as unambiguous as possible. AB 1581 currently makes minor technical corrections to language used in the CKH Act. Del Norte LAFCO is grateful to your Committee, staff and CALAFCO, all of whom worked diligently on this language to ensure there are no substantive changes while creating a significant increase in the clarity of the CKH Act for all stakeholders.

This legislation helps insure the Cortese-Knox-Hertzberg Act remains a vital and practical law that is consistently applied around the State. We appreciate your Committee's authorship and support of this bill, and your support of the mission of LAFCOs.
