### **DISCUSSION**

The FY 2021-2022 year-end accounting is attached. City & County revenues received.

One application filed in the prior FY completed this FY, no additional funds needed.

MSR/SOI Preparation costs are \$31,976.75 of the budgeted amount of \$32,000.00, as of June 2022, leaving \$23.25- or less than 1% remaining while Professional Services including both Executive Office and Administrative services are \$40,080.00- leaving \$20.00 remaining.

New Legal Counsel added last year (Jim Underwood) expenses incurred this FY \$1,802.50.

New public member (Lyle Armstrong) added last year, however stipend not accepted so no expense.

Insurance Costs, incurred at start of FY, \$2,614.83 were slightly over budgeted amount.

CALAFCO Membership costs, of, \$1,379.00 were slightly under budgeted amount.

Application processing costs were well below the budgeted amount at \$900.00. This is \$9,100.00 under the allocated \$10,000.00.

Overall, Del Norte LAFCo ended FY 2021-22 under budget by \$51.97.

### **DISCUSSION**

The FY 2022-2023 Mid Year accounting is attached. Revenues from both the County of Del Norte and the City of Crescent City have been received.

One application filed in the prior FY completed this FY, additional funds needed.

MSR/SOI Preparation costs are \$7,610 of the budgeted amount of \$32,000.00, as of December 31, 2023, leaving \$24,390 or 76% remaining while Professional Services including both Executive Office and Administrative services are \$20,060 leaving \$22,040 remaining.

Expected staffing and MSR/SOI Preparation expenditures over the remaining 2 quarters of the fiscal year expected to be within budgeted amounts.

Legal counsel expenses have been incurred this FY.

The public member has declined stipend.

Insurance Costs, incurred at start of FY, \$2,781.71 were slightly over budgeted amount.

CALAFCO Membership costs, also incurred at start of FY, \$1,447 were equal to the budgeted amount.

Overall, Del Norte LAFCo is currently under budget.
